PURPOSE:

To ensure that Traralgon South Primary School provides appropriate support to students with health care needs.

OBJECTIVE:

To explain to Traralgon South Primary School's parents, carers, staff and students the processes and procedures in place to support students with health care needs at school.

SCOPE:

This policy applies to:

- All staff, including casual relief staff and volunteers; and
- All students who have been diagnosed with a health care need that may require support, monitoring, or medication at school.

POLICY:

1. This policy should be read with Traralgon South Primary School's First Aid, Administration of Medication, Anaphylaxis and Asthma policies.

2. Student Health Support Planning:

In order to provide appropriate support to students at Traralgon South Primary School who may need medical care or assistance, a Student Health Support Plan (see Appendix A attached) will be prepared by a member of staff, in consultation with the student, their parents, carers and treating medical practitioners.

Student Health Support plans help our school to assist students with:

Routine health care support needs, such as supervision or provision of medication;

- Personal care support needs, such as assistance with personal hygiene, continence care, eating and drinking, transfers and positioning, and use of health-related equipment; and
- Emergency care needs, such as predictable emergency first aid associated with asthma, seizure, or diabetes management.

Students with complex medical care needs, for example, tracheostomy care, seizure management or tube feeding, must have a Student Health Support Plan which provides for appropriate staff to undertake specific training to meet the student's particular needs.

At enrolment or when a health care need is identified, parents/carers should provide accurate information about the student's condition or health care needs, ideally documented by the student's treating medical/health care practitioner on a Medical Advice Form, or relevant equivalent (see Appendix B attached).

Traralgon South Primary School may invite parents and carers to attend a Student Support Group meeting to discuss the contents of a student's Health Support Plan and assistance that the student may need at school or during school activities.

Where necessary, Traralgon South Primary School may also request consent from parents and carers to consult with a student's medical practitioners, to assist in preparing the plan and ensure that appropriate school staff understand the student's needs.

Student Health Support Plans will be reviewed:

- When updated information is received from the student's medical practitioner;
- When the school, student or parents and carers have concerns with the support being provided to the student;
- If there are changes to the support being provided to the student, or
- On an annual basis.

3. Management of Confidential Medical Information:

Confidential medical information provided to Traralgon South Primary School to support a student will be:

- Recorded on the student's file; and
- Shared with all relevant staff so that they are able to properly support students diagnosed with medical conditions and respond appropriately if necessary.

COMMUNICATION:

This policy will be communicated to our school community in the following ways:

- Available publicly on our school's website
- Discussed at staff meetings
- Reminders in our school newsletter
- Hard copy available from our General Office upon request


